State of Karnataka (SC) 2003 (2) SCT 385. The relevant portion of the above said judgment is reproduced as under:-Private education is one of the most dynamic and fastest growing segments of post-secondary education at the turn of the twenty –first century. A combination of unprecedented demand for access to higher education and the inability or unwillingness of government to provide the necessary support has brought private higher education to the forefront. Private institutions with a long history in many countries, are expanding in scope and number, and are becoming increasingly important in parts of the world that relied almost entirely on the public sector.

FUNDAMENTAL RIGHT & REASONABLE RESTRICTION UNDER CONSTITUTION OF INDIA

Hon'ble High Court's Lucknow Bench, Stay Order No. 744/91 Hon'ble Supreme Court Writ Petition 676/2014 by a Private Board HUMAN RIGHT PROTECTION ACT Under HUMAN RIGHTS PROTECTION ACT,1993 autonomous bodies have been given special protection—Hon'ble Supreme Court's Judgment: AIR 1993 SC-2178.—Dated 12-07-2013, Hon'ble Supreme Court of India gives order in the favour of A Private Board about the admissions of pass out candidates.—The only reasonable restriction on the exercise of this right can be imposed Under Article 19 (1) (g) and is imposed in clause 19 (6). The only restrictions that State can make the law imposing reasonable restriction in the interest of general public or any restriction regarding profession and technical qualification necessary for practicing any profession or occupation, trade or business. Since so far no such professional or technical qualification have been notified, therefore, the trustees/members of the Parishad through their Society have a fundamental right to carry on the profession /occupation of running the Institutes which imparts education. **Private boards are not illegal: Says Court (From Hindustan Newspaper 09-09-2004) HON'BLE SUPREME COURT ORDER IN THE FAVOUR OF PRIVATE BOARDS & consideration.(For further details refer: AIR 1993 SC-2178.)**

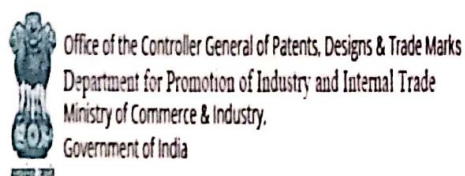
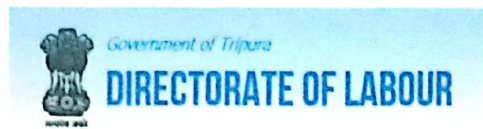

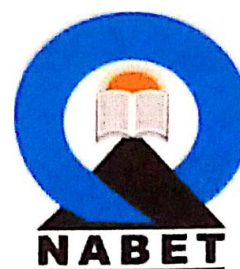

Features and Flexibilities in SOSEBT

Age Limit: There is no upper age limit for admission. However, the minimum age for enrolment is 14 years for the Secondary course and 15 years for the Senior Secondary course as per information given in the entry requirements.

Choice in Medium of Instructions:

- @ There are only English & Bengali mediums at the Secondary stage.
- @ Same as here English,Bengali mediums at the Senior Secondary stage.

Additional Subjects : The learner has the option to select one or two additional subject(s) either at the time of admission or during the course of study, if he/she so desires or if it is required.

Continuous Assessment : During course of study, internal assessment of learners progress will be done through Tutor Marked Assignments (TMAs) Flexible Scheme of Admission: The learner has the option to take admission in through **SOSEBT** Online under various Streams directly or by approaching a nearby Study Centre/Authorised **SOSEBT** Facilitation Centre .

Flexible Scheme of Examinations: The Public examinations are conducted by NIOS twice a year. A learner gets nine chances to appear in the public examinations over a period of five years to complete his/her courses. However, the learner has also the option to choose any of the following for getting evaluated and certify.

- Public examinations conducted by **SOSEBT** twice in a year/Session-**April/May & October/November**

Transfer of Credit: The learner has the option to avail the facility of Transfer of Credit (TOC) up to a maximum of two subjects passed from a recognised Board of School Education, provided these subjects are also available in **SOSEBT** Scheme of Studies and their results can be verified from the concerned Boards' website **TOC** is given as per the conditions given by **SOSEBT**.

Validity of Admission: The learner's admission is valid for a period of five years. For Public Examination at the Secondary and the Senior Secondary level, a learner may take nine or fewer chances to successfully complete the course during the validity period of admission.

Part Admission: There are no any Part Admission Conduct By **SOSEBT**.

The learners of SOSEBT at Secondary/Senior Secondary level who have completed their validity period of five Years Of Date Of Admission.

- (i) Online Admission Form without uploading required supporting documents will be rejected and fee will not be refunded..
